In addition, Boosters has raised \$2,485.00 in merchandise sales, approximately \$12,000.00 in annual t-shirt sponsorships, \$485 in proceeds from Coast Hippie's apparel sales, \$2,700.00 from Moms and Monsters, \$1,274.00 from Jingle and Mingle and \$9,254.00 netted from Winter Wonderland. YTD expenses include \$12,220.00 in classroom donations providing \$200 to 61 classrooms, \$750.00 for the new homecoming parade float supplies, four iPads for ESE and typing subscription as instructional resources for the school, \$\$79,500.00 for the new outdoor and playground area sunshades, \$5,300.00 on staff appreciation luncheons, \$2,659.00 on Tears and Cheers Back to School Event at Distillery 98, \$86.00 on popsicles for the Heart Walk and \$200.00 on Cafeteria Appreciation Week.

Financial Update - Jennifer Gray stated that the Boosters current bank balance as of January 23rd was \$30,374.69. The bank statement as of December 29th was \$36,289.66.

Winter Wonderland - Jamie Lynn thanked everyone for their help with the baskets. Only two baskets were left unsold following the event.

Daddy-Daughter Dance - Jamie Lynn stated that the Daddy-Daughter Dance will be held February 10th. She thanked all of the current sponsors and encouraged everyone to purchase their tickets and to sign up to help with the event. Principal Michie also suggested gathering faculty support.

Literacy Nights - Jamie Lynn stated that Literacy Nights will take place both Tuesday, January 23rd from Kindergarten through 2nd grade and Wednesday, January 24th for 3rd through 5th grades. She encouraged parents to attend.

Remaining Events and Dates for the 23-24 School Year - Jamie Lynn reviewed over the remaining events for the year which include the February Valentine's Door Decorating Contest taking place 2/1 though 2/13, our largest annual Fun Run fundraiser held March 14th, Field Day held April 19th, Kindergarten Round Up, Teacher Appreciation Week held May 6th through 10th, Mother's Day Mingle held May 13th at the Citizen, Kindergarten Celebration May 23rd and 5th Grade Graduation May 24th.

Upcoming Dune Lakes Dines - AttyCats Arcade will host Dune Lakes Dines February 2nd from 2:30 to 5:30 p.m. and Nigel's Watersound will host February 23rd from 4:00 to 6:00 p.m. Both are donating 20% of their proceeds. In addition, Brozinni's will be hosting again during the month of March and Local Cantina potentially for the month of April.
